- 22-178 Award Contract for Disposal of Tree Logs (NTE \$750/30 cubic yard container, \$50,000 total) –** Awards a contract for the removal of tree stalks and logs to the lowest responsible quote from RVH Mulch Supply, LLC, 455 West Main Street, Wyckoff, NJ, which is a “qualified end user” of recyclable materials, as required by law
- 22-179 Award Contract - Swift 911 Emergency Alert and Notification System (\$9,095) –** Awards a one-year renewal for this service to Rave Wireless, Inc., d/b/a Rave Mobile Safety, 14 Industrial Avenue, Suite 4, Mahwah, NJ. The cost of this will be split 50% paid by Ridgewood Water and 50% paid by the Village of Ridgewood. Also authorizes the Mayor, Village Manager, and Village Clerk to sign the contract.
